**STALLION SERVICE CONTRACT**  
**Stallion Fee - \$1,100.00**

**Booking Fee.....\$200.00 + GST**

I..... (“Mare owner”) hereby agree with Texas Star Quarter Horses (“TSQH”) on.....to breed the mare,.....  
(Registration #.....AQHA Year Foaled.....)  
(Registration #.....ASHS Year Foaled.....)

to the Stallion, **QP Clover Doc** for the 2016 season.

- The Stallion Fee stated above **includes a non-refundable booking fee** which shall be payable upon execution of the contract. The balance shall be payable when the mare is pronounced 45 days in foal, or when the mare is picked up from the breeding facility, after having been inseminated, whichever is the earlier.
- Mare owner agrees to pay all veterinarian and any other expenses as required.
- The mare will be at the mare owner’s risk at all times.
- The mare shall be healthy and in sound breeding condition; free from infection, contagious or transmittable disease. The mare must be halter broke. A photocopy of the registration papers should accompany the mare or be emailed to TSQH.
- TSQH will not give a Live Foal Guarantee for any mare if the mare has not been pregnancy tested at 45 days by a certified veterinarian.
- If the mare fails to conceive during the normal breeding season or fails to give birth to a live foal or a foal that is able to stand and suckle within 24 hours of birth and, if the mare owner notifies TSQH of such failure within 21 days, time being of the essence, then, provided that, in the reasonable opinion of TSQH, the failure was not caused by a lack of care by the mare owner for the mare, the mare owner will be entitled to a free return but only during the breeding season immediately following the season in which the failure occurred.
- A “Breeders Certificate” will be issued for the foal conceived by the mating when TSQH has had all stallion fees and all other expenses paid in full.
- Should the Stallion die or become unfit for service for any reason TSQH will return booking fee.
- If the mare dies or should become unfit to breed, then this contract shall become null and void and both parties are relieved of any further obligation hereunder and any monies paid by the mare owner toward the Stallion Fee, with the exception of the NON-REFUNDABLE BOOKING FEE, shall be refunded by the Mare Owner. However, Mare Owner shall pay for all other expenses actually incurred.
- THE LIVE FOAL GUARANTEE IN THIS CONTRACT IS NON-TRANSFERABLE AND NON-ASSIGNABLE. Should the mare be sold or otherwise disposed of prior to the birth of the foal, the Live Foal Guarantee shall be void. However, TSQH, may, at their discretion upon application and payment of a new booking fee, continue to honour the Live Foal Guarantee granted to the original owner. In the event TSQH agrees to the transfer or assignment of the Live Foal Guarantee granted under the terms of their contract, the mare owner will procure that the new owner agrees to be bound by all terms and conditions hereof, insofar as the same may then be applicable.

- This contract shall be binding upon the parties hereto, upon execution hereof, and the same may not be altered or amended, except by written mutual consent of the parties hereto.
- This contract is provided for one (1) live foal and one (1) breeders certificate. Should multiple embryos occur from the mare under this contract, then an additional contract and breeding fee for each embryo will be necessary.
- If the mare owner wants to have shipped semen from the Stallion sent to their mare the following will apply. Semen will be collected at Tamworth Equine Veterinary Centre.
- Mare owner will pay for the shipping of the semen and collection fee. Semen will be sent to the Veterinarian that is inseminating the Mare. Mare owner will pay for the shipping container to be sent back to Tamworth Equine Veterinary Centre.
